

ANDŽĀNS, Māris

Māris Andžāns is the Director of the Center for Geopolitical Studies Riga. He is also an Associate Professor at Riga Stradins University and Vice Rector at Vidzeme University of Applied Sciences. Previously, he worked for the Latvian Institute of International Affairs. He was a Visiting Fulbright Scholar at the Johns Hopkins University School of Advanced International Studies. Dr. Andžāns has ten years of experience in the public administration of Latvia. He served in positions related to the coordination of EU and NATO issues, security of transport and communications, civil-military cooperation, aviation, electronic communications, and postal issues. Among other duties, he has served as the Chairman of the National Cyber Security Council of Latvia. Prior to his academic and civil servant career, he was a professional weightlifter. He won multiple Latvian and Nordic champion titles and set more than 30 Latvian records.

BINDENAGEL, James D.

James D. Bindenagel is a retired U.S. Ambassador, Henry Kissinger Professor, Emeritus at Bonn University, and Senior Non-Resident Transatlantic Fellow at the German Marshall Fund of the United States. With nearly 50 years of professional experience, he has many years of experience in his professional network. He is noted for his achievements, leadership qualities, and the credentials and successes he has accrued in his field. As a career diplomat, he was U.S. Special Negotiator for the Kimberley Process Certification Scheme that banned conflict diamonds. Mr. Bindenagel was United States Ambassador and Special Envoy for Holocaust Issues, acting U.S. Ambassador (Chargé d'Affaires) in the U.S. Embassy to the Federal Republic of Germany, and deputy ambassador (deputy chief of mission) at the Embassy of the United States of America to the German Democratic Republic (East Germany) during the 1989-1990 Peaceful Revolution. He served as an Officer in the United States Army, director of government-business relations at Rockwell International, and subsequently as Vice President at the Chicago Council on Global Affairs and DePaul University in Chicago.

CASIER, Tom

Tom Casier is Reader in International Relations at the University of Kent's Brussels School of International Studies (BSIS). He led BSIS as Academic Director from 2014 to 2017 and is currently Director of the Global Europe Centre. He held a Jean Monnet Chair. Tom Casier's research focuses mainly on Russian foreign policy, EU-Russia relations, and the EU and its eastern neighbours. Recent articles have appeared in Cambridge Review of International Affairs, Cooperation and Conflict, Geopolitics, Democratization and others. An edited volume entitled EU-Russia Relations in Crisis: Understanding Diverging Perceptions (with Joan DeBardeleben, 2018) and one entitled Hegemony and world order (with Piotr Dutkiewicz and Jan Aart Scholte, 2021) were published with Routledge. He led a Jean Monnet project on EU-Russia relations with four Jean Monnet chairs. He has also provided policy advice for different institutions and organisations, including the European Parliament, House of Lords and the US State Department.

ENGELBREKT, Kjell

Kjell Engelbrekt is Professor of Political Science at the Swedish Defence University, Senior Non-Resident Fellow at the Chicago Council on Global Affairs and Lifetime Member of the Royal Swedish Academy of War Sciences. He has been a visiting scholar at the European University Institute, the Humboldt-Universität, Columbia University and the University of Illinois at Chicago, and between 2016 and 2021 he held a visiting professorship at Stockholm University. Engelbrekt has published in journals such as European Foreign Affairs Review, European Law Journal, The European Legacy, Ethnopolitics, Global Affairs, Global Governance, Global Policy and International Politics. Recent books are: High Table Diplomacy: The Reshaping of International Security Institutions (Washington DC: Georgetown University Press, 2016) and Bulgarian Democratic Institutions at Thirty: A Balance Sheet (Lanham, MD: Lexington Books, 2020), coedited with Petia Kostadinova. He is also a coauthor of Digital Media and the Dynamics of Civil Society: Retooling Citizenship in the New EU Democracies (Lanham, MD: Rowman & Littlefield), published 2021.

HAAR, Roberta N.

Roberta N. Haar is the Principal Investigator for the REMIT Horizon Europe Project, a 4 year project (€3 million budget partly funded by the UK government). REMIT consists of an interdisciplinary team of over 30 international researchers from 9 European universities and institutes that aims to use technology policy innovation to strengthen multilateralism. She is also Professor of Foreign Policy Analysis and Transatlantic Relations as well as the Research Director at University College Maastricht. She coordinates and supervises several International Relations related courses and projects at Maastricht University. Her research and publications focus mainly on the analysis of European and American foreign policy. Recent publications include the co-edited book The Making of European Security Policy: Between Institutional Dynamics and Global Challenges, published by Routledge as part of its Studies in European Security and Strategy. She writes a column entitled Across the Atlantic with the Dutch national news magazine EW and is a regular commentator on U.S. foreign and domestic policy and Transatlantic relations.

JANKOWSKI, Dominik P.

Dominik P. Jankowski is a Polish security policy expert, diplomat, and think tanker. He currently serves as Policy Adviser in the Office of the NATO Secretary General. From 2018 to 2022 he was Political Adviser and Head of the Political Section at the Permanent Delegation of Poland to NATO. Prior to this, he has held numerous international security related roles within public administration (Ministry of Foreign Affairs, National Security Bureau) and military (General Staff of the Polish Armed Forces). He specializes in NATO-Russia and NATO-Ukraine relations, arms control, disarmament, and non-proliferation, energy security as well as Eastern European affairs. In 2019, he was James S. Denton Transatlantic Fellow with the Center for European Policy Analysis (CEPA). In 2021-2022 he was Arms Control Negotiation Academy (ACONA) Fellow with the Harvard University. He is a prolific writer with over 250 publications which appeared in 20 countries. His recent publications include: "NATO in the Era of Unpeace: Defending Against Known Unknowns" (Institute of Central Europe, Lublin-Brussels, 2021), "NATO and the Future of Arms Control" (NATO Defense College, Rome, 2021), "Assessing the 2022 National Security Strategy: A View from NATO's Eastern Flank" (National Institute for Public Policy, Washington, D.C., 2023), "Energy Transition: How NATO Can Get it Right" (Council on Geostrategy, London, 2023).

JØRGENSEN, Knud Erik

Knud Erik Jørgensen is Professor at Aarhus University. He is a co-editor of the book series Palgrave Studies in International Relations and the European Union in International Affairs. Publications include *The Sage Handbook on European Foreign Policy* (co-ed 2015); *International Relations Theory: A New Introduction* (Palgrave 2017); co-edited with Oriol Costa, *The Influence of International Institutions on the European Union: When Multilateralism hits Brussels* (Palgrave 2012); co-edited with Katie Laatikainen, *Handbook on the European Union and International Institutions: Performance, Policy, Power* (Routledge 2013). Articles have appeared in *European Journal of International Relations*, *Journal of European Integration*, *Journal of European Public Policy*, *Cooperation and Conflict*. He is involved in the COST Action ENTER Network, the EUNPD Network and EURDIPLO, a research project on the EEAS. His most recent books are *What is International Relations?* (2021) *The Liberal International Theory Tradition in Europe*. (2021).

MOSER, Carolyn

Carolyn Moser conducts research in the field of international and European law, with a special focus on security and defense in Europe. Her Max Planck research group ENSURE (European security revisited), which deals with the law and governance of European security in the new geopolitical age in an interdisciplinary way (law & political science), also bears witness to this thematic orientation. She is furthermore an adjunct lecturer at universities in Germany and France and affiliated with the Institute for European Integration in Hamburg. Her key peer reviewed publications include a monograph on *Accountability in EU Security and Defence* (Oxford University Press, 2020) and a co-edited book on *The Legal Framework of the OSCE* (Cambridge University Press, 2019). Her most recent publications feature an in-depth analysis of on the prerogatives of the European Parliament in the field of European Security and Defense Policy and an interdisciplinary article on the (de) constitutionalization by the European Court of Justice with a focus on security policies (ICON, 2022). Dr Moser received several awards for her research, notably the Otto-Hahn-Medal and the European Court of Auditors Award. She was trained in both law and political science at Sciences Po Paris and The Fletcher School of Law and Diplomacy (Tufts University, USA), and holds a PhD from Utrecht University on EU civilian crisis management.

OZAWA, Marc

Marc Ozawa is a Senior Researcher at the Research Division at NATO Defense College. His current research examines NATO-Russian relations, hybrid conflict, and Russian and Eurasian affairs. He has previously held teaching, research and editorial positions at the University of Cambridge, IHS CERA, Yale University, and the *Yale Journal of International Affairs*. Marc has taught and supervised both undergraduate and graduate level students in the subjects of international relations, Russian foreign policy, and the geopolitics of energy. He has published works on Russia's relations with its neighbors, energy security and European-Russian relations. Marc was the lead editor of the book titled, *In Search of Good Energy Policy* (Cambridge University Press 2019) and is completing a book on European-Russian relations. He recently co-authored and lead a multidisciplinary group on Russian-Chinese energy cooperation called, the "Power of Siberia: a pipeline good for whom?", and co-authored a chapter with Michael Pollitt on conducting multidisciplinary research (both chapters - *In Search of Good Energy Policy* - from CUP).

ROMANYSHYN, Iulian

Iulian Romanyshyn is a fellow at the Academy of International Affairs NRW and a senior fellow at the Center for Advanced Security, Strategic and Integration Studies (CASSIS) at the University of Bonn. He previously held research and teaching positions at New York University, Maastricht University, Free University of Brussels, and European University Institute, as well as research fellowships at the Charlemagne Prize Academy and the NATO Defense College. Iulian's research interests include transatlantic security relations, EU security and defence policy, Black Sea security and EU-Ukraine relations. His research has been published in several peer-reviewed journals, including the Journal of Common Market Studies, International Journal, Journal of European Integration, and European Foreign Affairs Review. Iulian's research has been acknowledged with the 2018 Global Strategy PhD Prize awarded by the Egmont-Royal Institute for International Relations and the European Security and Defence College. Iulian holds a PhD in political science from the IMT School for Advanced Studies Lucca, master's and bachelor's degrees from Maastricht University, College of Europe (Bruges), and the National University of Kyiv-Mohyla Academy.

TYUSHKA, Andriy

Andriy Tyushka joined the European Neighbourhood Policy Chair as a Research Fellow in November 2016, having previously held a Post-Doctoral Fellowship position with the Chair in 2014, and since 1 October 2019, is a Senior Research Fellow. He is also part of the 'ENGAGE' (2021-2024) research project, an EU-funded project under the European Commission's 'Horizon 2020' research programme focusing on 'Envisioning a New Governance Architecture for a Global Europe' (<https://www.engage-eu.eu>). Prior to joining the College of Europe Natolin, Dr Andriy Tyushka held research and teaching positions in Spain (University of Deusto), Germany (German-French Institute in Ludwigsburg), and, most recently, Estonia (Baltic Defence College), where in 2016, he was awarded the BALTDEFCOL Service Cross for outstanding service. He was also a research fellow in the Department of International Relations and Diplomacy at the Ivan Franko National University of Lviv (Ukraine), where he obtained his M.A. and Ph.D. in International Relations and World Politics. Dr Tyushka's research focuses primarily on (Eastern) European security (Ukraine, Poland, Russia); the EU's (Eastern) neighbourhood, foreign and security policy, including the EU association agreements and structural power in the neighbourhood; Franco-German European politics; constitutional studies (Ukraine, EU); and strategic narratives and partnerships in international relations.

WEBER, Joachim

Joachim Weber holds a master in history, a Ph.D. in political geography and teaches as Senior Fellow of CASSIS political science at University of Bonn, focusing on strategic challenges, the maritime domain and most recently on the ongoing war in Ukraine. Before joining CASSIS, Dr. Weber ran the High North Project at Institute for Security Policy Kiel University (ISPK) in 2017-2019 and published two books on the Arctic. He has taught numerous courses in history, political geography and political science at the universities of Hamburg, Bonn, Zagreb and Akron, OH for more than two decades. Paralleling his academic career, Dr. Weber spent more than 15 years in the German Federal Service, including various positions in Federal Office for Civil protection and Disaster Management, Ministry of Economic Cooperation and Development (BMZ) and Ministry of Economics (BMW). Besides his scientific publications, he is a very frequent commentator in TV and other media.
